Casual Sports Club Constitution – 2017-2018

Article 1: Club Name and Purpose

The name of this organization shall be Casual Sports Club. The purpose of this organization is to provide events for Ohio State students to play sports and meet new people.

Article 2: Non-Discrimination Policy

This organization does not discriminate on the basis of age, ancestry, color, disability, gender identity or expression, genetic information, HIV/AIDS status, military status, national origin, race, religion, sex, sexual orientation, protected veteran status, or any other bases under the law, in its activities, programs, admission, and employment.

As a student organization at The Ohio State University, Casual Sports Club expects its members to conduct themselves in a manner that maintains an environment free from sexual misconduct. All members are responsible for adhering to University Policy 1.15, which can be found here:

Article 3: Membership

Membership is given to an Ohio State student once they have been added to the mailing list. Should a member violate the constitution and/or by-laws, the officers will meet with the organization advisor and call a vote for the member's removal from the organization. A unanimous vote from all officers and the advisor is required for removal. Should a member be removed, he/she will be removed from the mailing list and asked not to return to meetings.

Article 4: Leadership

President:

- Manages roster and mailing list
- Helps plan events, and notifies body of organization for upcoming events

Treasurer:

• Oversees and manages the organization's funds

Director of Advertising:

• Primary creator of advertising materials

Should an officer fail to perform his/her duties or act in violation of the constitution and/or by-laws, the officers shall have a meeting with the advisor in attempt to fix any problems. Should an officer continue to fail to perform his/her duties, the officers shall have another meeting with the advisor and vote for the removal of the offending officer. A unanimous vote is required to remove an officer. If an officer is removed, the other two officers will appoint a new person in the office until the next election.

Article 5: Elections

Elections shall be held on the last meeting of the year. Any Casual Sports Club member present at the meeting will be able to vote. Any member can email the officers before the meeting to be placed on the ballot. In addition, any members wishing to run that did not email before the meeting can submit their name on the ballot at the meeting.

Article 6: Method of Amending Constitution

Any proposed amendment will be presented to the members of the organization through an email, including the date of the vote for the amendment. A majority vote of the members present at the meeting is required to pass the amendment.

Article 7: Method of Dissolution

Should the officers feel that it is in the organization's best interest to be dissolved because of lack of interest or participation, the officers shall notify all members and the advisor that the possibility of dissolving the organization is being discussed. Two meetings must pass to give the general membership time to input their opinions. Should two meetings pass and the officers still feel that dissolution is the best decision, the officers will have a meeting with the advisor and make a decision whether or not to dissolve the organization. Should the organization be dissolved, all assets will be given back to The Ohio State University and all debts will be covered by the officers.
