Article I: Purpose

The Sierra Student Coalition works to bring the mission of the Sierra Club: "Explore, Enjoy, and Protect the Planet" to the Ohio State University campus:

- 1.1 Explore today's environmental questions through educational events.
- 1.2 Enjoy the natural world through outings.
- 1.3 Protect our planet through stewardship and environmental advocacy.

Article II: Non-Discrimination

2.1 This organization and its members shall not discriminate against any individual(s) for reasons of age, color, disability, gender identity or expression, national origin, race, religion, sex, sexual orientation, or veteran status.

Article III: Membership

- 3.1 Membership is limited to currently enrolled undergraduate and graduate members at The Ohio State University.
- 3.2 All other members of the OSU community may become non-voting members.
- 3.3 To become a member someone need only attend weekly meetings and participate in one or more of the four committees.
- 3.4 Any member whose actions are antagonistic to the purpose of the group may have their membership status suspended by a majority vote of the executive board until the next general meeting. At the next general meeting, status will be reviewed and a general vote will be taken to revoke the membership status.

Article IV: Officers

- 4.1 This organization shall have the following officers:
 - 4.1.1 President
 - 4.1.1.1 The president shall be the official representative of the organization to any other organization, to The Ohio State University, and the surrounding community.
 - 4.1.1.2 The president shall preside over all general meetings.
 - 4.1.1.3 The president shall be responsible for ensuring that general meetings are scheduled regularly.

4.1.2 Vice President

4.1.2.1 The vice president shall help preside over all general meetings and will run meetings in the absence of the president.
4.1.2.2 The vice president shall assist the president with his or her assigned duties.

4.1.3 Treasurer

- 4.1.3.1 The treasurer shall be responsible for the finances of the group.
- 4.1.3.2 The treasurer shall be required to sign all checks and vouchers for the group.

4.1.4 Secretary

4.1.4.1 The secretary shall be responsible for keeping time at all general body meetings and recording any decisions made during these meetings.

4.1.5 Media Chair

- 4.1.5.1 The media chair shall be responsible for managing and updating the group's social media accounts.
- 4.1.5.2 The media chair shall be responsible for publicizing the group and its upcoming events

4.1.6 Sustainability Council Representative

- 4.1.6.1 The sustainability council representative represents the Sierra Student Coalition at all Sustainability Council meetings
- 4.1.6.2 The sustainability council representative shall report significant announcements and decisions made at Sustainability Council meetings to the general body during weekly meetings

4.2 Election and Removal of Officers

4.2.1 Election

- 4.2.1.1 Elections shall be held each year during the first two weeks of April for each officer position
- 4.2.1.2 Officers shall be elected by a simple majority of members who have attended at least three meetings or organizational events
- 4.2.1.3 All general voting shall be done by secret ballot
- 4.2.1.4 Elected officers shall assume their roles in May

4.2.1.5 It is the responsibility of leaving officers to transfer any organizational passwords, bank accounts, and other valuable information to the new officer prior to leaving office

4.2.2 Removal

- 4.2.2.1 Any member may motion for removing an officer during a general body meeting
- 4.2.2.2 An officer shall be removed if a 2/3 majority should decide so through a secret ballot counted by whoever motioned for removal and by another elected officer

Article V: Committees

- 5.1 The committees listed may operate independently and decide their own leadership structure
- 5.2 With approval from the president or vice president, any group of four or more members may form a new committee
- 5.3 The committees include, but are not limited to: Education, Advocacy, Service, Outings
 - 5.3.1 The education committee shall promote environmental and sustainability education on campus
 - 5.3.2 The advocacy committee shall pursue positive environmental or social change through activism
 - 5.3.3 The service committee shall organize environmental stewardship projects
 - 5.3.4 The outings committee shall promote the enjoyment of the outdoors by organizing outdoor activities and field trips
