OSU Booktok Constitution

Purpose Statement:

To bring together those with a love for fiction novels popularized on TikTok and foster a creative and encouraging environment for discussion about the books themselves and the social issues brought up in the texts, relating them to the world today.

Member Selection and Removal Criteria:

Membership will be open to any undergraduate student who is interested in joining. Attendance will be taken at meetings and communication will be done through mass email and GroupMe. Attendance is not mandatory for general body members.

Members will be removed if...

- Disrupting club meetings after an initial warning
- Discriminates against anyone in the organization
- Infringes on any member's physical or emotional well being
- Commits unsafe practices after warning
- Is expelled or suspended from The Ohio State University
- Publicly slanders the name of the organization or anyone involved

Officer Positions and Duties

• President: will oversee and lead each meeting, will take action to remove a member if needed, will attend all meetings, will appoint rest of leadership positions, will remove one from leadership position if needed, will help create

agenda for each meeting, will arrange meetings with rest of leadership team to make sure all organization goals are met

- Vice President: will assist president with duties listed above, will find and book meeting spaces, will be present at all leadership meetings and over half of the general body meetings, will work with rest of exec team to come up with discussion questions for each meeting
- Treasurer: will handle all of the organization's funding, will complete mandatory training, will complete purchases needed for the organization, will be present at all leadership meetings and over half of the general body meetings, will take recommendations for Books of the Month and handle the voting process
- Secretary: will take attendance during meetings, will help communicate events / meetings with general body, will help provide resources to general body members, will be present at all leadership meetings and at over half of the general body meetings
- Social Media Chair: will run social media accounts such as TikTok, Instagram, Twitter, etc., will create infographics / flyers for recruitment purposes, will be present at all leadership meeting and at over half of the general body meetings
- Chair Positions: must be present at over half of the leadership meetings and at over half of the general body meetings
 - Social Chairs: two social chairs will be appointed and work alongside treasurer to plan social events for general body members
 - Diversity and Inclusion Chair: works alongside V.P. to ensure each Book of the Month, Book of the Month suggestions, and authors are appropriate

and do not discriminate in regards to race, ethnicity, background, sexuality, etc., will also be in charge of communicating any sort of triggering topics to general body members before going forward with a Book of the Month

- Librarian: works alongside V.P. to find and inform general body members on resources to procure each Book of the Month in a cost efficient and easily attainable manner, will also be in charge of ensuring that each Book of the Month suggestion is a book popularized or reviewed on the social media platform, TikTok
- Communications Chairs: two communications chairs will be appointed and work alongside the Social Media Manager and Secretary to communicate updates about the organization to general body members and assist with outreach.

Officer Selection and Removal Criteria

Officers will be appointed by the President for Spring 2022-Spring 2023 followed in later years by a popular vote conducted by all members present at the meeting dedicated to electing new leadership.

Officers will be removed from their positions for...

- Failure to perform assigned duties effectively
- Showing up to less than half of the meetings per semester without discussing it with the President
- Removal from club altogether

- Expulsion or suspension from The Ohio State University
- Demonstrating behaviors / language / mannerisms that do not produce a supportive, safe environment
