Buck-I-Watch Constitution

Article I: Name

This club organization shall be officially named Buck-I-Watch.

Article II: Purpose

Buck-I-Watch aims to create a community for Ohio State sports fans through socially responsible Buckeye football and basketball away-game watch parties. Our mission is to bring back to Columbus the same Buckeye spirit and camaraderie we all so passionately feel while packed into our home stadiums. We use this community to foster school spirit, introduce like-minded individuals, encourage new fandom, enliven the diehards, and ensure that nobody ever has to watch another game alone!

Article III: Membership

Member Selection:

Membership is open to any and all students, faculty, and staff at The Ohio State University. Buck-I-Watch does not discriminate on the basis of age, ancestry, color, disability, gender identity or expression, genetic information, HIV/AIDS status, military status, national origin, race, religion, sex, sexual orientation, protected veteran status, or any other bases under the law, in its activities, programs, admission, and employment.

Member Removal:

If a member conducts themselves in such a manner deemed detrimental to advancing the purpose of this organization or is in violation of the OSU Student Code of Conduct, they can be removed through a majority officer vote, with the consultation of the advisor.

Article IV: Meetings

Meetings are to be held at a variety of on and/or off-campus venues (including but not limited to, residence halls, meeting rooms, classrooms, bars and restaurants) during designated away games throughout Ohio State's football and basketball seasons.

Article V: Officers

Officer Positions and Duties:

The club leadership shall consist of the Executive Committee. The Executive Committee shall be comprised of a president, treasurer, secondary leader, secretary and an advisor. A single person may not hold more than one position and the Executive Committee membership shall not fall below four (4) persons nor shall it exceed above (8) persons. Other than this single governing body, there will be no other standing committees, and

responsibility shall be delegated only as deemed appropriate by members of the Executive Committee. The Executive Committee shall meet as deemed necessary by the Committee members. The current executive committee is as follows:

- President: Blaze Fletcher-Broderson Plans watch parties/fundraising events and oversees member recruitment/retention.
- Secondary Leader: Jacob Brodson Aids in planning organizational events and member recruitment/retention
- Treasurer: William Kinzie Organizes financing, including a running spreadsheet with estimated and actual expenses.
- Secretary: Matthew Dersovitz Helps with any additional operations needed to ensure club success.
- Advisor: Sebastian Ignacio Munoz Ruz Ensures that Buck-I-Watch is annually registered and operating as intended.

Officer Selection:

Officers shall be appointed via an election process beginning in the Spring semester of the 2025 school year. This election process will be open to all members and held on a competitive application basis. A prospective officer can apply for any of the above positions.

Officer Removal:

If an officer conducts themselves in such a manner deemed detrimental to advancing the purpose of this organization, is delinquent in performing their officer duties, or is in violation of the OSU Student Code of Conduct, they can be removed through a majority member vote or unanimous vote of the other officers, with the consultation of the advisor.
