## Minecraft Club Constitution

## Article I

Section I- Name: Minecraft Club (MCC)
Section II- Purpose: At Minecraft club we are focused on creating, building, and exploring in order to promote newly developed relationships, expand our knowledge all while creating an inclusive environment for everyone while playing the game we all love and enjoy.
Section III- Non-Discrimination Policy: Minecraft Club does not discriminate on the basis of age, ancestry, color, disability, gender identity or expression, genetic information, HIV/AIDS status, military status, national origin, race, religion, sex, sexual orientation, protected veteran status, or any other bases under the law, in its activities, programs, admission, and employment.
Section IV- Sexual Misconduct Policy: As a student organization at The Ohio State University, Minecraft Club expects its members to conduct themselves in a manner that maintains an environment free from sexual misconduct. ## Article II

## Categories of Membership:

A. All students full/part time at The Ohio State University are eligible for general membership into Minecraft Club.
B. General Members can attend in person meetings and play virtually on the worlds created.

## Article III

## Methods for Removing Members and Executive Officers:

A. If a member engages in behavior that is detrimental to advancing the purpose of Minecraft, violates the organization's constitution or by-laws, or violates the Code of Student Conduct, university policy, or federal, state or local law, the member may be removed through a majority vote of the officers in consultation with the organizations advisor.
B. Any elected officer of the chapter may be removed from their position for cause. Cause for removal includes, but is not limited to: violation of the constitution or
by-laws, failure to perform duties, or any behavior that is detrimental to advancing the purpose of this organization, including violations of the Student Code of Conduct, university policy, or federal, state, or local laws. The Executive Committee may act for removal upon a two-thirds affirmative vote of the executive board in consultation with the advisor.
C. In the event that the reason for member removal is protected by the Family Educational Rights and Privacy Act (FERPA) or cannot otherwise be shared with members (e.g.. while an investigation is pending), the executive board, in consultation with the advisor, may vote to temporarily suspend a member or executive officer.

## Article IV

## Organization Leadership:

A. President

- President is in charge of creating annual goals, connecting with the advisor, making sure annual registration requirements are met, and finding space for meetings.
- Attending and leading all in person and virtual meetings.
- Actively playing on the realm and managing realms activity to see that people are following the constitution and by-laws, and making sure realm subscription is still activated.
- Coordinating with members inside the GroupMe.
- Accepting members into the realm.
- Looking after other departments such as treasurer, marketing, and vice-president.
- Attends all executive officer meetings.
- Completes President Officer Training at Ohio State.
B. Vice-president
- In charge of marketing on instagram.
- Helps coordinate and attend all in-person and virtual meetings.
- Helps maintain people are adhering to by-laws in the Minecraft realm.
- Leader in recruiting new members.
- Attends all executive officer meetings.
C. Treasurer
- Helps maintain people are adhering to by-laws in the Minecraft realm.
- Control the organization's bank account.
- Applies for funding.
- Helps coordinate and attend all in-person and virtual meetings.
- Attends all executive officer meetings.
- Completes Treasurer Officer Training at Ohio State.
D. Each Executive Officer will serve their term for one year, and new ones will be appointed to the Executive Office.


## Article V

## Election/ Selection of Organization Leadership:

A. Elections will be held in the spring, and positions will begin the following autumn semester.
B. All active club members can run for positions.
C. All active members who attend the election meeting can vote.

## Article VI

## Executive Committee: Size and composition of the committee: Each Executive

 board member, president, vice-president, and treasurer may elect any one to be a part of their committee as long as they are an active member.
## Article VII

## Advisor:

A. Advisors of student organizations must be full-time members of the University faculty or Administrative \& Professional staff. If a person is serving as an advisor who is not a member of the above classifications, a co-advisor must be chosen who is a member of these University classifications.
B. Advisor must complete the required training every two years and oversee the club to make sure guidelines are met.
C. Executive board should be responsible if the advisor is meeting these requirements.

## Article VIII

Meetings and events of the organization: Required meetings and their frequency:
A. In person meetings are not required but highly encouraged for general members.
B. Members must be active on the online realm at least once a week.

## Article IX

## Attendees of events of the organization:

A. Minecraft club reserves the right to address member or event attendee behavior where the member or event attendees behavior is disruptive or otherwise not in alignment with the constitution.
B. Violating members' virtual items and builds on the realm, if not otherwise stated before play can result in being kicked from the virtual realm.

## Article X

## Method of Amending Constitution: Proposals, notice, and voting requirements:

 Proposed amendments must be presented in writing or electronically before they are put into action. The amendment will be read in the executive meeting where a vote will be taken to agree or disagree. Two thirds executive members must agree before it is implemented. The constitution should not be amended easily or frequently.
## Article XI

## Method of Dissolution of Organization:

A. Club may be dissolved at the end of each semester with two third officer vote.
B. If three positions of president, vice president, and treasurer can not be filled at the start of each semester it may be dissolved.
C. If the club has any assets, they should first be distributed to any debts, if anything is left over, they may donate it to a charity they find appropriate.
