Constitution

The Ohio Air Mobility Symposium

Article I - Name, Purpose, and Non-Discrimination Policy of the Organization

Section 1: Name

The name of the organization will be known as "The Ohio Air Mobility Symposium".

Section 2: Purpose

The purpose of the chapter shall be as follows:

- Knowledge Sharing and Networking: This club will be an opportunity to share current updates in the AAM industry, hold presentations and speakers to add to our understanding of Advanced Air Mobility, and hold networking events to build connections with people in the industry.
- Symposium Preparation and Participation: Executive members of the club will plan and
 organize the yearly symposium to showcase the progress of Advanced Air Mobility and
 hold a networking night, panels, and exhibitor booths. Everyone in the club will attend
 the symposium to have a chance to learn from keynote speakers, professionals, and
 other students.
- 3. Professional Development: The club will hold networking preparation events and business card workshops to improve every member's professional development.

Section 3: Non-Discrimination Policy

This organization does not discriminate on the basis of age, ancestry, color, disability, gender identity or expression, genetic information, HIV/AIDS status, military status, national origin, race, religion, sex, sexual orientation, protected veteran status, or any other bases under the law, in its activities, programs, admission, and employment.

Article II - Membership

As required by the Guidelines for Student Organizations, 90% of the membership of a student organization must include current Ohio State University students. Active members are able to make decisions regarding the membership of the community and other non-student members of

an organization. Community or other non-student members may be suspended or removed by the President in consultation with the organization's advisor.

Any person who is a registered student at The Ohio State University regardless of race, gender, sexual orientation, religion, and discipline of study is welcome to be a member of The Ohio Air Mobility Symposium. All members of the chapter are subject to the Constitution and Bylaws of The Air Mobility Symposium.

Article III - Organization Leadership and Officer Selection Process

President: Serves as administrative head and is responsible for overall team function and organizational structure.

Vice President: Assists the President with duties and fills in when the President is not available.

Treasurer: Responsible for handling all monetary transactions of the team and working with the officer team on any necessary administrative tasks.

In future years, the officers will be selected by the retired President of the organization. They will choose the next president, vice president, and treasurer for the upcoming year.

Article IV - Methods for Removing Members and Executive Officers

Officers and members may be removed from the team if the president and the faculty advisor deem their presence detrimental to the function of the team.

Article V - Advisor(s) or Advisory Board: Qualification Criteria

Advisors of student organizations must be members of the University faculty or Administrative and Professional staff. The advisor serves as the group's liaison with the university and provides guidance when requested by the members of the group.

Article VI - Meetings of the Organization: Required meetings and their frequency

Meetings will be conducted as needed throughout the year in accordance with the current needs of The Ohio Air Mobility Symposium and symposium schedule.

Article VII - Method of Amending Constitution

Proposed amendments should be submitted to the executives in writing. They will be sent to the entire group and voted upon at the final meeting of the year. Approval requires a ¾ affirmative vote.

Article VIII - Method of Dissolution of Organization

The organization shall be disbanded if there is no upcoming president. The organization's assets will be distributed to other organizations or the university in a manner seen fit by the advisor.
