

## Constitution

### *Article I - Name, Purpose, and Non-Discrimination Policy of the Organization*

---

#### Section 1: Name: Casual Sports and Service

Section 2 - Purpose: The purpose of the Casual Sports & Service Club is to provide a platform for individuals interested in participating in various recreational sports games and activities. Through a combination of casual sports events and organized volunteer opportunities, the club aims to promote physical activity, teamwork, and community engagement among its members. Additionally, the club seeks to foster a sense of camaraderie and social connection among individuals who share a passion for both sports and community service.

#### Section 3 - Non-Discrimination Policy:

“Casual Sport and Service is committed to building and maintaining a diverse community to reflect human diversity and to improve opportunities for all. The university is committed to equal opportunity, affirmative action, and eliminating discrimination. This commitment is both a moral imperative consistent with an intellectual community that celebrates individual differences and diversity, as well as a matter of law. The club does not discriminate on the basis of age, ancestry, color, disability, gender identity or expression, genetic information, HIV/AIDS status, military status, national origin, race, religion, sex, sexual orientation, protected veteran status, or any other bases under the law, in its activities, programs, admission, and employment.”

### *Article II - Membership: Qualifications and categories of membership*

---

The club will be open to any and all current undergraduate students at The Ohio State University. Prospective members can reach out to club executives, send a message to the Instagram page, or contact any member of the club to join. A club GroupMe page will be used to share information about events. Students who reach out can be approved to join the club by any member of the executive board. Students who are not current undergraduate students at The Ohio State University may join the club based on executive board decision. A membership is completely free and voluntary. Membership involves access to club GroupMe page and club events.

*Article III – Methods for Removing Members and Executive Office*

---

Membership can be revoked based on majority decision by the executive club. Any member may have their membership revoked for any reason if voted by the executive board. Executive board members may be removed by the acting president at any time if deemed necessary.

*Article IV - Organization Leadership*

---

The president will be in charge of setting the vision for the organization, acting ethically, building future leaders, communicating with executive board, overseeing club operations, completing annual registration requirements, keeping in touch with advisor, and filling in gaps left by other executive members.

The vice-president will assist the president with the roles above.

Treasurer will act ethically to spend funds for the organization, approve and monitor spending, maintaining an accurate and timely budget and bank records, and applying for funding by the university.

Secretary and Mental Health Advisor will keep track of attendance at events, volunteer hours, and set up mental health recourses/presentations for members.

Service and Safety Coordinator will be in charge of seeking and setting up community service events. They will also be in charge of making sure all events are safe for members and minimize potential risk or injury.

Event Coordinator and Strength/Conditioning Coach will be in charge of coordinating events and coach students who may be new to a sport.

Recruitment and Social Chair will be in charge of recruitment, social media, and fundraising.

*Article V- Election / Selection of Organization Leadership*

---

Elections will be held every April for open positions. Additional positions may be added based on club need or as determined by the executive board.

Academic advisor will be a full-time member of the University staff. Advisor will be chosen and kept updated by the president. Meetings will be held as often as the executive board elects. Club will not be limited in size as all students are welcome to join and attend meetings. Attendance will not be required by members to stay active. Either attendance or contact with an executive board member will hold a membership as active. The board has the right to revoke any memberships that appear unactive. Constitution may be amended by president as the president sees fit. Dissolution of organization may occur if decided by majority of the executive board.
