

# Geoguessr Club at Ohio State Constitution

## Article 1

**Section 1 – Name:** Geoguessr Club at Ohio State

**Section 2 – Purpose:** The purpose of Geoguessr Club is to foster a community of Geoguessr players at Ohio State by providing resources to improve and hosting casual and competitive events.

**Section 3 – Non-Discrimination Policy:** This organization and its members shall not discriminate against any individual(s) for reasons of age, color, disability, gender identity or expression, national origin, ethnicity/race, religion, sex, sexual orientation, veteran status, and/or skill-level.

As a student organization at The Ohio State University, Indie Game Buckeyes expects its members to conduct themselves in a manner that maintains an environment free from sexual misconduct. ## Article 2

**Section 1 – Membership:** Any student at the Ohio State University is eligible to be a member of Geoguessr Club. Membership is given by attending a meeting, joining the Discord, and/or participating in events.

## Article 3

**Section 1 – Removal of Members:** Members who engage in behavior detrimental to the purpose of Geoguessr Club or the student code of conduct may be removed through a majority vote of the officers.

**Section 2 – Removal of Officers:** Officers who engage in behavior detrimental to the purpose of Geoguessr Club or the student code of conduct may be removed through a majority vote of the other officers after consultation of all officers with the advisor.

## Article 4

### Section 1 – Leadership Positions

A. President Duties

- a. Meeting annual registration requirements
  - b. Finding space for meetings
  - c. Leading meeting
  - d. Organizing tournaments
  - e. Advertising the group
- B. Treasurer
- a. Meeting annual registration requirements
  - b. Applying for funding
  - c. Leading meetings
  - d. Organizing Tournaments

**Section 2 – Term Lengths:** Each officer will hold their position for one year.

**Section 3 – Elections:** Elections will be held in the spring with positions to be begin in the following fall. All active club members may run for and vote for officer positions.

#### Article 5

**Section 1 – Amendments:** New amendments must be proposed to the officers and general body. Unanimous agreement among officers is needed for the amendment to be implemented.

**Section 2 – Dissolution:** Geoguessr Club may be dissolved at the end of a semester with a unanimous vote from officers and the advisor.
