## Article I- Name, Purpose, and Non-Discrimination Policy of the Organization-

The name of this organization is Taking Back Our Campus at Ohio State University.

Taking Back Our Campus (TBOC) is a college ministry established from the local Columbus church, Hope City Church. We are dedicated to fulfilling the Great Commission by making disciples who follow and obey Christ, are transformed by Him, and are committed to making more disciples. Together, we seek to glorify God by fostering deep relationships, prayer, and spiritual growth.

Taking Back Our Campus, and its members shall not discriminate against any individual(s) for reasons of age, ancestry, color, disability, gender identity or expression, genetic information, HIV/AIDS status, military status, national origin, race, religion, sex, sexual orientation, or veteran status.

### Article II- Membership: Qualifications and categories of membership-

Membership: All meetings are open to all students, staff, or faculty at Ohio State University. Currently enrolled students at Ohio State are eligible to become general members of Taking Back Our Campus.

<u>Duties of President</u>: Organizes and oversees Monday night prayer meetings and books rooms for Thursday Bible study.

Duties of Vice President: Assists President for Monday night and manages roster.

<u>Duties of Treasurer</u>: In charge of financial needs and decides how many flyers to purchase and if T-shirts will be distributed.

At the beginning of each fall semester, students vote for the President, Vice President, and Treasurer.

#### Article VI- Method of Selecting and/or Removing Officers and Members-

## Article VII- Advisor(s) or Advisory Board: Qualification Criteria-

Advisors of student organizations must be members of the University faculty or Administrative & Professional staff. Advisors are responsible for meeting all of the practical requirements within the university to ensure yearly active membership as well as provide counsel for student officers and members.

## Article VIII - Meetings of the Organization: Required meetings and their frequency-

Meetings are held weekly during Autumn and Spring semesters. Weekly prayer meetings are held on Monday nights at 8pm on the oval (if in climate weather, meetings are held indoors). Weekly Bible studies are held on Thursday nights at 8pm at the Ohio Union.

## Article IX – Method of Amending Constitution: Proposals, notice, and voting requirements-

If a student member desires to amend the constitution, the amendment needs to be in line with the purpose of the organization and at least 75% of the organization needs to be in favor of the amendment.

## Article X – Method of Dissolution of Organization-

Upon dissolution of Taking Back Our Campus, the Leadership Committee, after paying or making provision for the payment of all the liabilities of the organization, shall donate all of the remaining funds to the local church or other Christian mission agencies to advance the spreading of the gospel of Jesus Christ.
