#### Constitution of the Taiwanese Student Association

### **ARTICLE I. ORGANIZATION**

### TITLE

The name of this association shall be the Taiwanese Student Association (TWSA). It shall be affiliated with the ethnic/cultural organizations at The Ohio State University.

### **PURPOSE**

- To support and assist students from Taiwan in adapting to the university environment.
- To strengthen relationships among Taiwanese students and foster connections with non-Taiwanese students.
- To increase awareness and recognition of Taiwan among non-Taiwanese individuals through the promotion of Taiwanese culture.
- To function as a service-oriented organization with no profit-seeking interests.

#### NON-DISCRIMINATION POLICY

This organization does not discriminate on the basis of age, ancestry, color, disability, gender identity or expression, genetic information, HIV/AIDS status, military status, national origin, race, religion, sex, sexual orientation, protected veteran status, or any other basis under the law, in its activities, programs, admission, and employment.

As a student organization at The Ohio State University, the Taiwanese Student Association expects its members to maintain an environment free from sexual misconduct. #### **ARTICLE II. MEMBERSHIP**

# **MEMBERSHIP**

- **Member:** Any student currently enrolled at, or an incoming student of, The Ohio State University with a valid BuckID is eligible to join the association at any time. By joining the private Facebook group, one automatically becomes a member of the organization.
- Honorary Member: Non-student individuals who support the objectives of TWSA may become honorary members. By joining the private Facebook group, one automatically becomes a member of the organization.

# **PRIVILEGES**

- Members have the right to attend TWSA activities and access benefits provided by sponsors.
- Members have the right to elect or remove any officer of TWSA.
- Honorary members share the same privileges as general members, except they are not eligible to run for elected positions.

### **OBLIGATIONS**

• Members must adhere to the TWSA Constitution.

### ARTICLE III. ADVISOR

# ADVISOR(S)

- The advisor for TWSA shall be nominated and invited by the General Assembly.
- The advisor must be a faculty member or professional administrative staff at The Ohio State University and is required to attend a workshop every three years.

# **ARTICLE IV. FUNDING**

### **FUNDING**

- The allocation of funds shall be determined by the Executive Board each year.
- The Executive Board must inform members of the organization's financial status each academic quarter.

#### **ARTICLE V. VOTING PROCEDURES**

# **GENERAL ASSEMBLY**

- The General Assembly shall convene annually during the spring semester.
- The General Assembly holds the highest authority within the organization.
- Emergency meetings may be called with the approval of either a majority of the Executive Board or 20% of the membership.
- The General Assembly serves as the forum for officer elections and constitutional amendments.

### **SELECTION OF OFFICERS**

The Executive Board consists of seven officers responsible for the governance of TWSA.

- Officers are elected in the spring semester and serve for one academic year.
- The seven Executive Board positions include: President, Vice President, Treasurer, Secretary, Webmaster, and two Activities Heads.
- The President is elected through an anonymous vote among the elected Executive Board members.
- The President, Vice President, and Treasurer must register with the university. The President and Treasurer are required to attend university introductory workshops.

### **EXECUTIVE BOARD DUTIES**

#### President

- Represents TWSA and attends Office of International Affairs (OIE) and other university meetings.
- Serves as the official spokesperson of TWSA in media and press interviews.
- Organizes welcome events for new students.

# **Vice President**

- Establishes and maintains connections with the Taiwanese Association of America Columbus Chapter, Taiwanese Collegian, and other student organizations.
- Oversees the printing, assembly, and distribution of the TWSA newsletter.
- Manages and updates the member roster.

#### **Treasurer**

- Manages the financial affairs of TWSA, including preparing and presenting budget reports to the General Assembly.
- Regularly checks and maintains the TWSA P.O. Box.

# Secretary

- Records minutes for all meetings.
- Maintains official documentation, including Executive Board reports and membership records.
- Oversees the editing, printing, and distribution of the TWSA "Taiwan Forum."

#### Webmaster

- Maintains the TWSA website and mailing list.
- Updates announcements, events, and photos on the website.

### **Activities Heads**

- Plan and coordinate events, design promotional materials, and host guests.
- Organize social gatherings and networking events.

# **REMOVAL OF A MEMBER**

- A complaint must be filed by at least two general members and one officer.
- The accused member will be notified and required to attend a meeting with the Executive Board to present their case.
- A majority vote by the Executive Board will result in one of the following actions:
  - 1. Removal from TWSA for the remainder of the academic year.
  - 2. Probation with an opportunity to rectify the issue and regain full membership.
  - 3. No action taken, allowing the member to retain their status.

### REMOVAL OF AN OFFICER

- If an officer fails to fulfill their duties or violates the TWSA Constitution, they may be removed by a majority vote of both the general membership and the Executive Board.
- If removed, the officer may choose to remain as a general member or appeal the decision at a General Assembly meeting.
- A 3/4 majority vote from the General Assembly and a majority vote from the Executive Board will determine the final decision.

# ARTICLE VI. AMENDMENTS TO THE CONSTITUTION

### AMENDMENT PROCEDURE

- A constitutional amendment must be proposed by either a majority of the Executive Board or 20% of the membership.
- Amendments require approval from 2/3 of the members present at the General Assembly meeting.

# **ARTICLE VII. DISSOLUTION**

# **DISSOLUTION PROCEDURE**

- The dissolution of TWSA must be proposed by at least half of the officers or one-third of the members.
- Approval requires a 2/3 majority vote at the General Assembly.
- Upon dissolution, all remaining funds and assets shall be donated to the Taiwanese Association of America Columbus Chapter.
