

## ***Article I***

### ***Name***

Section 1: The name of this organization is "614college"

## ***Article II***

### ***Purpose & Goals***

Section One: 614college is the college ministry of 614church and is purposed with the goal of supporting 614 Church and its mission.

Section Two: 614college honors the established Ohio State University policies, State and Federal Laws.

## ***Article III***

### ***Membership***

#### **Attendees**

All persons are welcomed at all events hosted by 614college.

#### **Members**

Membership is open to all students at Ohio State who support the purposes of the organization. All members are welcome and accepted upon their filling out of a form that they are offered each week at our meeting.

#### **Revocation of Membership**

Any individual's membership, including the leadership of any Officer and/or Advisor, may be revoked for actions that hinder or go against the constitutional agreement of purposes of the organization. Students who no longer wish to participate or need to be removed will have a conversation with the President or VP. The President and VP will decide unanimously if the member should be removed from the organization. Once a decision is made the President will have the conversation with the member and they will be removed from membership within 614college.

## ***Article IV***

## **Officers**

### **Officer Requirements**

Officers should have demonstrated a commitment to the purposes of the organization. In addition they must

- a. *Have a minimum cumulative grade point ratio (GPA) as stated below and meet that minimum GPA in the semester immediately prior to the election/appointment, the semester of election/appointment and semesters during the term of office. For undergraduate students, the minimum cumulative GPA is 2.00. In order for this provision to be met, at least six hours (half-time credits) must have been taken for the semester under consideration.*
- b. *Be in good standing with the university and enrolled: at least half time (six or more credit hours), if an undergraduate student (unless fewer credits are required to graduate in the spring and fall semesters) during the term of office, and at least half time (four or more credits), if a graduate level student (unless fewer credits are required in the final stages of their degree as defined by the Continuous Registration Requirement) during their term of office.*
- c. *Be ineligible to hold an office should the student fail to maintain the requirements as prescribed in (a) and (b).*

## **Officers**

The Officers of 614college shall consist of a President, Vice President, Secretary and Faculty Advisor.

### **Officer Duties**

The officer team works together to ensure quick and sound communication with all members. They serve to encourage and strengthen a healthy culture. They work to envision and set direction for the organization. The president serves as the captain of the team, but all members work together in all areas.

*President:* Leading vision and communication for officer duties. Communicating with university and ensuring all officers understand their roles. Leading officer meetings.

*Vice President:* Assisting the President and Secretary with their respective duties. Dealing with issues within the member pool and ensuring the execution of vision. The VP is expected to be at all meetings, including officer meetings.

Secretary: Takes meeting notes, communicates with members, and attends officer meetings.

### **Election of Officers**

In the Autumn term, a list of nominees for three student positions will be presented to 614college members electronically. This list will consist of individuals receiving votes from a majority of the outgoing officers and approved by the Faculty advisor. Once nominees are determined the individual with the majority of votes will be elected.

### **Term of Office**

The term of office will be approximately one year and will begin after the Autumn term election and continue until the election the following year. The term can be renewed for up to 4 years. In accordance with the membership policy (Article III), any officer's membership may be revoked for cause as noted in the section above.

### **Officer Duties**

The duties of the president are to communicate with the university on behalf of the organization, reserving meeting spaces, etc. The duties of the secretary are to keep meeting minutes, ensure up to date rosters, and handle communication with members. The VP will serve to assist the president when needed.

### **Advisor Appointment**

The advisor must be a faculty or staff member who supports 614college purpose. Advisor duties will include ensuring that the organization is operating in conformity with the standards set forth by Ohio State University and the Student Activities Center.

### **Officer/Advisor Removal**

Officers and/or Advisors may be removed from their positions by majority vote of the other officers. The officer is allowed to speak to the Executive Committee and general members about the charges made concerning his/her conduct.

### ***Article V. Non-Discrimination Clause***

614college will not discriminate in the acceptance of members, rank, or office on the basis of age, ancestry, color, disability, gender identity or expression, genetic information, HIV/AIDS status, military status, national origin, race, religion, sex, sexual orientation, protected veteran status or any other basis in accordance with Student Organization Registration and Funding Guidelines.

614college welcomes all persons.
